# PENNSYLVANIA VOTER ROLL ANALYSIS SETH KESHEL 8 AUGUST 2021

### **EXECUTIVE SUMMARY**

Five county sample describing potential for counties to oversee election fraud by planting or maintaining "phantom" voters on the rolls. Each county differs in mechanism and will be thoroughly described under each county heading.

## **ERIE COUNTY**

Capt. Keshel Estimate for Excess Biden Votes: 15,000

Erie County reports 81,305 votes cast for November 3, 2020, General Election exclusively cast by voters with a registration date reflecting the first day of a given month, with 202,389 registered at the time of the election.

This means that 40.2% of all voters registered for the 2020 election were registered on the 1<sup>st</sup> day of any given month ranging from 1901 to 2004. Yes, 1901. Many of these voters have a birthdate after their voter registration date. Keep in mind, these are ACTUAL VOTES recorded in this county that Trump flipped in 2016, but lost back despite a huge vote gain and corresponding GOP registration gain. There may be limited window to explain that voters get the first day of a month as a registration date if the info isn't fully available, but why are 59.8% of voters registered on a different date of a given month? These are your phantom voters.

#### **LUZERNE COUNTY**

Capt. Keshel Estimate for Excess Biden Votes: 15,000

Luzerne County, bellwether of PA, reports 78,424 voters out of 220,888 registered with a registration date of 2/5/1998, including one gentleman from Wilkes-Barre born in 1886, who waited until he was 112 to finally get involved in the democratic process, and put a ballot in for 2020 to celebrate turning 134. Clearly, I doubt that nearly half the votes in this county are fake, suggesting horrific record keeping in this county (what I'm saying is that I'm sure the 78,424 called out here has real voters included that for some reason are lumped to the mass 2/5/1998 registration date, but other serious issues with ancient voters on the rolls exist, as well.

#### FRANKLIN COUNTY

Capt. Keshel Estimate for Excess Biden Votes: 7,000

Franklin had 100,974 registered at the time of the election, and 22,764 people on that roll who voted were registered on January 1 of a given year. This was a pattern in York but not so in Washington and Westmoreland, two counties that were analyzed, confirming that this is not a statewide "glitch."

## **MONTGOMERY COUNTY**

Capt. Keshel Estimate for Excess Biden Votes: 30,000

Montgomery County has 141,801 voters from 2020 who had a registration date of August 29, 1996, out of 609,195 registered. I find it hard to believe that nearly one quarter of the voters in the county were registered on the same date in 1996. At best, horrible record keeping, at worst, tons of phantom voters under the guise of system errors and bad record keeping. As with Luzerne, I don't see how all of these can be phantoms, but this demands auditing of the voter rolls.

#### YORK COUNTY

Capt. Keshel Estimate for Excess Biden Votes: 25,000

Pasted from 8/7 Telegram Post:

York County, PA, had 311,108 registered on the rolls at the time of the 11/3/20 election.

In my numbers I have York County estimated at 25,000 heavy for Biden. Perhaps the county, who recently punted on audits, could explain this issue.

Given that 1/365 = 0.27%, how is it that 79,968 (25.7%) registered voters have a registration date of January 1 of any given year? I realize the county may not do business on certain dates, but really? Other dates are accounted for for the remaining 231,000 voters, but how do we explain this?

Is this the cache of phantom voters that has been hanging on to the rolls indefinitely? Certainly the county or the state can clear this up - or maybe Senator Corman or Rep. Grove?

I cannot release to you the entire roll due to personal identifiers but see this photo for what I'm talking about here.

The scourge of 1/1 registration dates goes from 1940 to 2017.

Answers. They are needed.
